IMPORTANT INFORMATION PLEASE READ CAREFULLY

ACCURACY OF INFORMATION – Full names on your Reservation Form must be exactly as they appear on identification. Boarding of airline flights and cruises will be denied if first and last names on reservations do not exactly match passenger identification and no refund will be issued.

TERMS AND CONDITIONS – The cruise line's terms and conditions, including cancellation policies and documentation requirements, apply. A copy of the cruise line's terms and conditions will be sent to you upon your request. It is important to carefully read all of the terms and conditions.

FEES & TAXES – Departure related fees (NCFs) and government taxes are included in the prices listed on the cruise flyer. Cruise Holidays has no control over these fees and taxes. They are imposed by the cruise line, airline, and/or responsible government agency, and are subject to change up to the time of departure.

IDENTIFICATION REQUIREMENTS – A valid passport is the recommended form of identification for all travel, and is required for non-US citizens. US citizens traveling on cruises originating from and terminating in the same US port, such as this cruise, are not required to have a passport. If you have a valid passport, that is the only identification required. If you do not have a valid passport, the required forms of identification are an original or certified birth certificate AND a government issued photo ID (driver's license). If the name on your birth certificate does not match the name on your driver's license, you will be required to have documentation showing why the names are different, ie: a marriage certificate. Regulations are subject to change. It is the responsibility of each passenger to confirm identification and other documentation requirements (www.travel.state.gov) and to have the required identification in his/her possession when checking in for flights and/or a cruise. Boarding will be denied without proper identification and no refunds will be issued.

CANCELLATIONS – Cancellation requests must be made in writing to Cruise Holidays and signed by the individual who made payment for the cruise. Cancellations are subject to cruise line cancellation penalties, which may be in effect prior to the final payment date for the cruise.

TRAVEL INSURANCE – Travel insurance is highly recommended, as it provides protection in the event a trip is canceled or interrupted due to covered circumstances. Information regarding travel insurance will be sent with the Cruise Invoice confirming each reservation.

FINAL PAYMENT – Payment must be received by Cruise Holidays no later than the date specified on the Cruise Invoice sent to confirm each reservation. The cruise line may cancel cruise reservations if payment is not received on time and no refunds will be issued.
